TERMS AND CONDITIONS

- 1. Foaling down:** Mares are taken at livery for foaling. The service includes CCTV and foaling alarm monitoring, foaling assistance, enema, after-care of the mare and foal, foal blood IgG level test. All under supervision of our resident Veterinarian. We advise that mares arrive at the Stud circa 3 weeks before the due date and travels back home with foal at least 7-10 days old.
- 2. Mare Booking-in Form:** Legal owner or keeper is requested to fill in and sign this form when they bring mare to stud. If the mare is sent with a third party the form must be downloaded, completed and sent with the horse.
- 3. Passport:** It is a legal requirement that all horses are accompanied to stud with their passports; we will check the identity of the horse with the passport on arrival.
- 4. Health status:** All mares arriving at the Stud will undergo brief clinical examination and only will be allowed to stay if the results are satisfactory. Please don't bring to the Stud horses that show any of the following: lack of appetite, fever, diarrhoea, swollen lymph nodes, nose discharge, cough, poor body condition, signs of ringworm or lice infestation.
- 5. Flu and tetanus vaccinations:** Owners are advised to have their mares regularly vaccinated against influenza and tetanus. We recommend to have your mare re-vaccinated circa 3 weeks before foaling as this will maximise passive transfer of antibodies to foal and reduce the risk of the foal getting sick with flu and most importantly – tetanus. This procedure will not be efficient if the mare has never been vaccinated before, in which situation we recommend that the foal is administered Tetanus Antitoxin in it's first days of life.
- 6. Hind Shoes:** Please make sure all mares arrive at the Stud without hind-shoes. Mares with hind-shoes on will either have their shoes removed at the owner's expense or kept stabled for the time being at the stud .
- 7. Blacksmith:** Horses will have their feet trimmed when necessary and any costs charged to the owner's account. Any specific shoeing requirements must be notified to the stud when the horse is booked in.
- 8. Worming:** Mares and foals will be wormed regularly and the owner charged accordingly.
- 9. Stud Veterinary Work:** Veterinary work relating to the Stud services will be undertaken by the resident Veterinary Surgeon Aleksandra Jagusiak MRCVS as she sees it appropriate. No responsibility can be accepted for injury, damage or loss caused through routine stud work like scanning, foaling assistance, administration of medicines, sedation etc. unless resulting from an act of negligence.
- 10. Veterinary Assistance:** In the event of an emergency or accident a Veterinary Surgeon will be called when deemed necessary. An effort will be made to consult the owner of the mare before veterinary work is done, but in case of an emergency and / or of the owner not being contactable the Veterinary Surgeon will take such action as is considered necessary and at the owner's cost.
- 11. Insurance:** Mares and foals whilst at Scotland AI Service will receive every possible care, attention and supervision, but the Stud accepts no responsibility whatsoever for accident, theft, disease or damage to any horse, person or property. It is the owner's choice to insure their own horses and carry insurance policy covering third party liability.
- 12. Payments:** The account for all fees and costs incurred must be paid before the horse leaves the stud. Interim invoicing will be done at the stud's absolute discretion once the horse has been here for four weeks. Owners who send a third party to collect the horse must make arrangements to pay in advance of collection. Horses will not be allowed to leave before payment is made in full. Scotland AI Service reserves the right to sell the horse in settlement of outstanding bill.
- 13. Dangerous behaviour:** Scotland AI Service reserves the right to refuse entry to the stud to any stallion, mare or foal that they consider to be an unacceptable risk to the safety of other horses or staff .
- 14. Not intended for human consumption:** Be advised that opting for keeping this section in the passport unsigned means that you can elect for abattoir slaughter at the end of the horse's life but greatly limits range of drugs vet can use and makes it necessary to keep a record of veterinary medicines administered. Therefore, in this situation, we will charge £20 fee that will cover additional paperwork when we administer any drugs.

FEES AND COSTS

The total cost of having your mare foaled down at Scotland AI Service will be the sum of the following:

1. Boarding Fee

- * At grass (includes haylage if needed): £5.00 (+VAT) / day for mares and £7.00 (+VAT) / day for mares with foal at foot
- * Stabled or stabled only at night (includes haylage and hard feed): £10.00 (+VAT) / day for mares and £12.00 (+VAT) / day for mares with foal at foot

2. Foaling Fee – £200 (+VAT)

includes CCTV and foaling alarm monitoring, foaling assistance, enema, after-care of the mare and foal, foal blood IgG level test

3. Miscellaneous – farrier fees, wormers, vaccines etc.

We also offer microchipping and sketch drawing for your foal's passport:

- * microchip implanting - £17 (+VAT)
- * passport sketch - £10 (+VAT)
