TERMS AND CONDITIONS

- 1. Insemination:** Mares are taken at livery for insemination with fresh, chilled or frozen semen, including semen sent from elsewhere. Insemination with fresh and chilled semen can be also performed on 'walk-in' mares. Ideally mare arrives at Stud when in season.
- 2. Mare Booking-in Form:** Legal owner or keeper is requested to fill in and sign this form when they bring mare to stud. If the mare is sent with a third party the form must be downloaded, completed and sent with the horse.
- 3. Passport:** It is a legal requirement that all horses are accompanied to stud with their passports; we will check the identity of the horse with the passport on arrival.
- 4. Health status:** All mares and their foals arriving at the Stud will undergo brief clinical examination and only will be allowed to stay if the results are satisfactory. Please don't bring to the Stud horses that show any of the following: lack of appetite, fever, diarrhoea, swollen lymph nodes, nose discharge, cough, poor body condition, signs of ringworm or lice infestation.
- 5. Vaccinations:** Owners are advised to have their mares regularly vaccinated against influenza and tetanus. Routine vaccinations will be carried out at the owner's expense if requested.
- 6. Hind Shoes:** Please make sure all mares arrive at the Stud without hind-shoes. Mares with hind-shoes on will either have their shoes removed at the owner's expense or kept stabled for the time being at the stud .
- 7. Blacksmith:** Horses will have their feet trimmed when necessary and any costs charged to the owner's account. Any specific shoeing requirements must be notified to the stud when the horse is booked in.
- 8. Worming:** Mares and foals will be wormed regularly and the owner charged accordingly.
- 9. Stud Veterinary Work:** Veterinary work relating to the Stud services will be undertaken by Aleksandra Jagusiak MRCVS, the resident Veterinary Surgeon, as she sees it appropriate. No responsibility can be accepted for injury, damage or loss caused through routine stud work like teasing, scanning, insemination, administration of medicines, sedation etc. unless resulting from an act of negligence.
- 10. USG rectal examination:** It is the stud policy to scan all mares prior to insemination to determine the optimum time for AI and post insemination. Further scans will be carried out at 14 - 17 days post ovulation to detect pregnancy and at 28 days to check for foetal heartbeat. Be advised that there is a small but inevitable risk of rectal damage when examining horses per rectum.
- 11. Veterinary Assistance:** In the event of an emergency or accident a Veterinary Surgeon will be called when deemed necessary. An effort will be made to consult the owner of the mare before veterinary work is done, but in case of an emergency and/or of the owner not being contactable the Veterinary Surgeon will take such action as is considered necessary and at the owner's cost.
- 12. Insurance:** Mares and foals whilst at Scotland AI Service will receive every possible care, attention and supervision, but the Stud accepts no responsibility whatsoever for accident, theft, disease or damage to any horse, person or property. It is the owner's choice to insure their own horses and carry insurance policy covering third party liability.
- 13. Payments:** The account for all fees and costs incurred must be paid before the horse leaves the stud. Interim invoicing will be done at the stud's absolute discretion once the horse has been here for four weeks. Owners who send a third party to collect the horse must make arrangements to pay in advance of collection. Horses will not be allowed to leave before payment is made in full. Scotland AI Service reserves the right to sell the horse in settlement of outstanding bill.
- 14. Dangerous behaviour:** Scotland AI Service reserves the right to refuse entry to the stud to any stallion, mare or foal that they consider to be an unacceptable risk to the safety of other horses or staff .
- 15. Not intended for human consumption:** Be advised that opting for keeping this section in the passport unsigned means that you can elect for abattoir slaughter at the end of the horse's life but greatly limits range of drugs vet can use and makes it necessary to keep a record of veterinary medicines administered. Therefore, in this situation, we will charge £20 fee that will cover additional paperwork.

FEES AND COSTS

Our goal is to put your mare in foal without putting the owner to big expense. The total cost of having your mare inseminated at Scotland AI Service will be the sum of the following:

1. Boarding Fees

- *At grass (includes haylage if needed): £5.00 (+VAT) / day for barren mares and £7.00 (+VAT) / day for mares with foal at foot
- *Stabled or stabled only at night (includes haylage and hard feed): £10.00 (+VAT) / day for barren mares and £12.00 (+VAT) / day for mares with foal at foot

2. Veterinary Fees

*Per cycle fixed vet fee (Covers routine reproduction work like all USG scans, inseminations, drugs used to control cycle, semen collections from stallions at Stud. Doesn't include swabs, twinning, Caslick, infertility treatment and other non routine matters.)

Fresh and chilled semen: £140 (+VAT) per cycle

Frozen semen: £240 (+VAT) per cycle

*Insemination only: fresh and chilled semen: £15 (+VAT)

*Scan only: £17 (+VAT)

*Other vet costs: infertility investigation and treatment, twin reduction, vaccinations etc.

3. Stud Fee – this is payable to the stallion owner.

4. Miscellaneous – farrier fees, wormers, semen shipping costs etc.
