TERMS AND CONDITIONS

- 1. Stallion Services:** We offer following services for stallion owners: dummy training, semen collection and evaluation, semen processing for fresh, chilled and frozen semen, semen shipping, CEM and EVA testing, standing stallion at Stud during breeding season.
- 2. Stallion Booking-in Form:** Legal owner or keeper is requested to fill in and sign this form when they bring stallion. If the stallion is sent with a third party the form must be downloaded, completed and sent with the horse.
- 3. Passport:** It is a legal requirement that all horses are accompanied to stud with their passports; we will check the identity of the horse with the passport on arrival.
- 4. Health status:** All stallions staying at livery at the Stud will undergo brief clinical examination and only will be allowed to stay if the results are satisfactory. Please don't bring to the Stud horses that show any of the following: lack of appetite, fever, diarrhoea, swollen lymph nodes, nose discharge, cough, poor body condition, signs of ringworm or lice infestation.
- 5. Vaccinations:** Owners are advised to have their stallions regularly vaccinated against influenza and tetanus. Routine vaccinations will be carried out at the owner's expense if requested. Additional vaccine to consider is EVA vaccine (Artervac). This needs to be initiated together with taking blood sample for EVA and then care needs to be taken that, after completion of primary course, a booster is given every 6 months. It is especially recommended for stallions that have contact with many other horses (competing, show stallions).
- 6. CEM and EVA tests:** Although not required by law if semen is collected and used within UK, we strongly advise that all stallions are CEM and EVA tested in the beginning of each stud season. Note that some vets, studs or mare owners will refuse to inseminate mares with semen from stallions that haven't proven CEM and EVA negative (or haven't been EVA vaccinated).
- 7. Blacksmith:** Horses will have their feet trimmed and shod when necessary and any costs charged to the owner's account. Any specific shoeing requirements must be notified to the stud when the horse is booked in.
- 8. Worming:** Stallions will be wormed regularly and the owner charged accordingly.
- 9. Stud Work:** Veterinary work relating to the Stud services will be undertaken by the resident Veterinary Surgeon Aleksandra Jagusiak MRCVS as she sees it appropriate. No responsibility can be accepted for injury, damage or loss caused through routine stud work like teasing, swabbing, dummy training, semen collecting, administration of medicines, sedation etc.
- 10. Veterinary Assistance:** In the event of an emergency or accident a Veterinary Surgeon will be called when deemed necessary. An effort will be made to consult the owner of the stallion before veterinary work is done, but in case of an emergency and / or of the owner not being contactable the Veterinary Surgeon will take such action as is considered necessary and at the owner's cost.
- 11. Insurance:** Stallions whilst at Scotland AI Service will receive every possible care, attention and supervision, but the Stud accepts no responsibility whatsoever for accident, theft, disease or damage to any horse, person or property. It is the owner's choice to insure their own horses and carry insurance policy covering third party liability.
- 12. Payments:** The account for all fees and costs incurred must be paid before the horse leaves the stud. Interim invoicing may be done at the stud's absolute discretion once the horse has been here for four weeks. Owners who send a third party to collect the horse must make arrangements to pay in advance of collection. Horses will not be allowed to leave before payment is made in full. Scotland AI Service reserves the right to sell the horse in settlement of outstanding bill.
- 13. Dangerous behaviour:** Scotland AI Service reserves the right to refuse entry to the stud to any stallion, mare or foal that they consider to be an unacceptable risk to the safety of other horses or staff .
- 14. Not intended for human consumption:** Be advised that opting for keeping this section in the passport unsigned means that you can elect for abattoir slaughter at the end of the horse's life but greatly limits range of drugs vet can use and makes it necessary to keep a record of veterinary medicines administered. Therefore, in this situation, we will charge £20 fee that will cover additional paperwork when we administer any drugs.

FEES AND COSTS

- 1. Boarding Fees**
 - * £15 (+VAT)/day - this includes stabling, haylage and hard-feed twice a day
- 2. Dummy training - £75 (+VAT)**
- 3. Fresh and chilled semen collection, evaluation and processing fees**
 - * fresh semen - £35 (+VAT)/collection
 - * chilled semen - £45 (+VAT)/collection. Shipping chilled semen with Royal Mail - £20 (+VAT) (includes postage and packaging)
- 4. Frozen semen** (Note: we freeze semen from stallions from beginning of October until end of March)
 - * test freeze - £150 (+VAT)
 - * additional doses - £30 (+VAT) per dose
- 5. Standing at stud** – for availability and conditions contact Ben (07749498152)
- 6. Miscellaneous** – farrier fees, wormer, semen shipping costs, vet fees, lab fees etc.
